### 'CURBING MENACE OF RAGGING IN INSTITUTIONS'

Dear Students & Staff,

In pursuance of the **Judgement** of the **Hon'ble Supreme Court of India** dated 8/5/2009 in **Civil Appeal No.887/2009**, the University Grants Commission has been asked to enhance the vigilance on occurrences of ragging of any nature. Cases that have come to light vary from petty frauds to emotional, mental or physical bullying, besides making and sharing morphed pictures and unethical texts.

Through their Circular **D.O.No.1-21/2010 (ARC)** dated, 4<sup>th</sup> November 2019, the **University Grants Commission** has directed all the Universities and Institutions of Higher Education to curb instances of ragging in Colleges. **The Mahatma Gandhi University** in the letter **No.3159/AC A1/2020/AC A1**, dated 19.02.2020 has also directed the Anti-ragging cell of Institutions to be vigilant in this regard and to **constantly remind** the students and staff of the consequences of the violation of the Anti-ragging rules.

You are also being warned to maintain your physical distance and request you to treat the other person/s with respect and dignity. The misuse of mobile phones and cases leading to cyber crimes will be monitored in the campus.
